

## Danske eksportdebutanter - opruster de på kvalifikationer?

### Formål:

Det overordnede formål er at belyse eksportdebuterende virksomheders beslutninger om at ændre sammensætningen af deres ansattes kvalifikationer i tiden før, under og efter, de debuterer.

I produktionen af varer og tjenester til eksport spiller kvaliteten af arbejdskraften en vigtig rolle. Vi ved fra korrelationsstudier, at eksportvirksomheder har en højere andel af medarbejdere med videregående uddannelse end andre virksomheder, men vi kender ikke den kausale sammenhæng. Skyldes det blot, at de eksporterende virksomheder er en anden ”breed” end ikke-eksporterende virksomheder (jf. Melitz, 2003) og derfor generelt anvender flere ansatte med videregående uddannelse, eller er det mere direkte en konsekvens af, at virksomhederne begynder at eksportere? Og hvis det er det sidste, sker denne oprustning da før virksomhederne debuterer som eksportører eller efter, de er begyndt at eksportere? Med andre ord, opstår behovet for højtuddannet arbejdskraft i forberedelserne til eksportdebuten eller i den efterfølgende produktion? Svarene på disse spørgsmål er helt centrale, hvis man skal forstå eksportvirksomheders efterspørgsel på arbejdskraft og kvalifikationer, og dermed også konsekvenserne af en ændret uddannelsesmæssig sammensætning af arbejdsstyrken.

Vores ide er derfor at undersøge, hvorvidt danske eksportdebuterende virksomheder opruster sammensætningen af deres ansattes kvalifikationer, og om dette sker før, under eller efter de indtræder på eksportmarkeder. Dermed ønsker vi at klarlægge en kausal sammenhæng mellem uddannelsesintensivering og eksportaktivitet.

Vi søger om støtte for 251.280 kr. til at gennemføre projektet med henblik på at kunne indsende en artikel til et tidskrift i kategori A som fx Journal of International Economics eller Journal of Labor Economics. Arbejdet vil blive påbegyndt 13. februar og vare frem til sommer 2014.

### Undersøgende spørgsmål og policy-relevans:

Danmark har et lille indenlandsk marked, og derfor ligger virksomhedernes muligheder for vækst ofte uden for landets grænser. Vi ved, at danske eksportvirksomheder i højere grad end andre virksomheder anvender arbejdskraft med videregående uddannelse (Fosse, Malchow-Møller, Munch & Sørensen, 2013), men om virksomhederne er blevet videnintensive før eller efter eksportdebuten, ved vi ikke.

Dette studie vil tilføre ny viden om, hvordan danske virksomheder opruster kvalifikationsmikset blandt deres ansatte i forbindelse med deres debut på eksportmarkeder. Vi har ikke kendskab til lignende analyser på danske data. Derfor vil studiet bidrage med ny viden om de forskellige uddannelsesgruppers anvendelse og anvendelighed i disse særlige virksomheder, som gennemgår en transition, hvor de skal til at konkurrere på udenlandske markeder, men også skal øge produktionskapaciteten for at kunne servicere et større marked. Modsat effekterne af outsourcing, som er relativt velbelyste i litteraturen, så ved vi meget lidt om, hvordan den relative fordeling af arbejdskraftresurserne udvikler sig, og timingen for udviklingen i disse, i eksportdebuterende virksomheder.

### Baggrund

Hvorfor eksporterer relativt få virksomheder, og hvorfor står ganske få eksportører for en stor del af et lands samlede eksport? Det er to spørgsmål, som har optaget forskningen i international økonomi i årtier. I den nyeste generation af teorier (*new-new trade theory*) argumenteres (og her refereres især til Melitz, 2003) for en forklaring, hvor virksomhederne har nogle faste omkostninger forbundet med at få et produkt på markedet (fx marketing). Disse omkostninger er højere, hvis virksomheden skal på eksportmarkeder (fx juridiske udfordringer samt sprog- og kulturarrierer), end hvis den kun skal sælge sit produkt på det danske marked. Desuden må de forventes at være forskellige for forskellige virksomheder. Som en konsekvens heraf vil kun nogle af virksomhederne blive eksportører.

Men hvad dækker disse faste omkostninger over? Vores hypotese er, at en del af dem skyldes investeringer i opkvalificering af arbejdskraften, og hvis eksportvirksomheder skal have videnbasen på plads for at konkurrere internationalt, så skal de have opbygget formelle kompetencer før eksportdebuten. I en nyere model viser Costantini & Melitz (2007) således, at forventninger om fremtidige bedringer i mulighederne for

indtræden på nye eksportmarkeder, får virksomhederne til at innovere på forhånd for at være klar til eksportdebut. En øget innovationsaktivitet kræver flere videnmedarbejdere. Spørgsmålet er naturligvis, om det også er tilfældet, at danske virksomheder forudser fremtidige eksportmuligheder og opkvalificerer på forhånd i håb om at blive mere konkurrencedygtige for at kunne klare sig på eksportmarkeder.

### **Metode og data:**

I Fosse et al (2013) for Rockwoolfondens Forskningsenhed anvender vi et panel fra 1999 til 2010 (som i nærværende projekt skal udvides med 2011) med kohorter af eksportdebutanter. Da der er forholdsvis få virksomheder hvert år, som skifter status fra ikke-eksportører til eksportører, er det essentielt at have et langt panel.

Vi har i Fosse et al (2013) anvendt en matchingmetode, hvor vi matcher hver eksportdebutant med en sammenlignelig, ikke-eksporterende virksomhed. Derudfra sammenligner vi udviklingen i uddannelsesintensiteter mellem de to typer virksomheder og tilskriver eksportbeslutningen forklaringen på forskellen i udviklingerne. Der er imidlertid visse udfordringer med metoden. Timingen i matchingen af virksomhederne og observationen af udviklingen gør, at vi behøver strenge antagelser for at kunne konkludere på udviklingen i årene frem mod en virksomheds eksportdebut. Det vi mangler er en (eller flere) variable, som påvirker virksomhedens beslutning om at eksportere, men som virksomheden ikke har indflydelse på. Med andre ord: Vi skal instrumentere virksomhedens forventede beslutning om i fremtiden at eksportdebutere og dermed håndtere eventuelle selektionsproblemer i tolkningen af forskelle mellem eksportdebutanter og kontrolvirksomheder.

Molina & Muendler (2013) ser i en beslægtet analyse på, om eksportdebutanter opkvalificerer medarbejderstabben, hvis de finder det sandsynligt, at de i nær fremtid eksportdebuterer. Instrumenterne, de anvender, vedrører information om forhold på udenlandske markeder. Vi har tænkt at forfølge en lignende strategi. Fordelen ved deres instrumenter er, at modsat gængse instrumenter (som fx store valutakursudsving), fungerer deres instrument godt i mere normale tider, og en stor del af stikprøveperioden var normal.

Hvor Molina & Muendler (2013) ser på væksten i antal ansatte med særlige kompetencer (eksporterfaring) under kontrol for øvrig beskæftigelsesvækst, så anlægger vi en indgangsvinkel, som belyser differentierede formelle kompetencer i virksomhederne. Vi ser både på relative forskydninger (som Molina & Muendler, 2013), men også på underliggende vækstrater for de enkelte kompetencegrupper, som trods ikke-mærkbare ændringer i uddannelsesandelene kan gemme på markante forskelle.
