Does the stock market affect private consumption?

Project description

Slumps in the real economy are often preceded by large and sudden declines on the stock market and economic recoveries are typically accompanied by stock market booms. This project aims to explore whether there is a causal link from the performance of the stock market to the cycles in the real economy working through household consumption: if stock owners cut spending when they suffer losses and raise it when they make gains, then swings on the stock market amplify the cycles of the real economy through their effect on aggregate demand.

The key empirical challenge is to measure consumption and stock market gains precisely. In response to this challenge, we have started a unique collaboration with a major Danish retail bank ("the Bank"). Banks record every single purchase made by their customers and these records make it possible to obtain a precise measure of consumption by summing all of the purchases made by a given customer in a given period (Gelman et al., 2014). The Bank's customer files also contain information about transactions on securities accounts, which allows us to compute gains and losses from portfolios of stocks. Both spending and stock market gains can be measured at the monthly, weekly or even daily frequency.

The econometric model will estimate whether consumer spending in period t is affected by stock market (realized and unrealized) gains in period t, t-1, t-2 and so on, while controlling for other determinants of spending (e.g. labor income) and for common shocks (e.g. policy changes). We may think of the model as comparing the spending of two stock owners who have similar portfolios, but earn different returns. Under the plausible assumption that the two would have exhibited a similar trend in spending if they had realized the same return, the model identifies the causal effect of stock market gains on spending.

The main result summarizes how much of a dollar of stock market gains is channeled into private consumption. This is of immediate use for governments and central banks who attempt to manage aggregate demand in the face of volatile stock markets.

The project relates to a large literature that studies how consumption responds to wealth shocks. Part of this literature considers shocks to housing wealth (e.g. Mian, Rao and Sufi, 2013), while another part is devoted to stock market shocks. The evidence is mixed with some recent papers finding that stock market gains has a significant positive effect on consumption (Christelis et al, 2015) and others finding no effect (Paiella and Pistaferri, 2016).

The main advantage of our project relative to existing work is the data quality. The current standard in the literature is to rely on surveys for information about consumption, which is known to suffer from significant and sometimes systematic measurement error. Stock market income is typically measured as the change in the value of stock holdings between two waves of the survey, which conflates the effect of price changes (wealth shocks) and portfolio changes (not wealth shocks). Finally, the analysis of household surveys is limited to a few thousand survey respondents. By contrast, our analysis will draw on precise information about consumer spending and stock market income for hundreds of thousands of customers at the Bank, which greatly enhances the credibility of the estimated average effects and creates ample opportunity to explore heterogeneity across different types of stock owners.

Given the importance of the research question and the scope to push the research frontier significantly forward, we believe that the project will lead to a paper with a real chance of publication in a top-5 economics journals. We have completed much of the preliminary data work, for instance the construction of monthly individual-level spending measures from transaction-level data, and thus expect to have a draft paper by the end of 2017.

This is the first project in a broader research agenda aiming to leverage customer data from the Bank combined with information from government registers. The research agenda has already received financial support from two external sources. First, Adam Sheridan is funded by an industrial phd stipend from the Innovation Fund. Second, we have received a grant from the Carlsberg Foundation to finance data infrastructure, travelling and conference organization. The main constraint at this stage of the project is the scarce research time of the two senior researchers on the project, Asger Lau Andersen and Niels Johannesen. We therefore apply for 2 months of research time for each.
